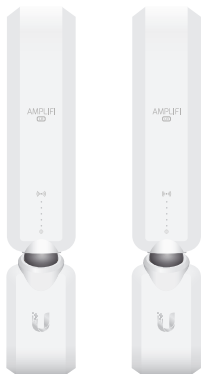

Hardware Overview

Front



Remove the electrostatic sticker from the front of the AmpliFi Router.



The front of the AmpliFi Router features a full-color touchscreen display.



The bottom of the AmpliFi Router features an LED with a brightness setting configurable in the AmpliFi app. By default, the LED is fully lit when configured and ready for use.

Back



1-4 Four Gigabit Ethernet ports available to connect 10/100/1000 Mbps wired network devices to the Internet.



Connects to the broadband modem provided by your ISP (Internet Service Provider).

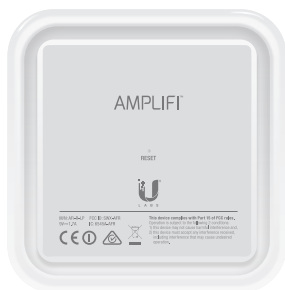


Reserved for future use.



The *Power Adapter* connects to this port.

Bottom



To reset the AmpliFi Router to the factory default settings, use an object such as a straightened paperclip or pin to press the *Reset* hole located on the bottom of the device for approximately 10 seconds until the LED turns off.

Using the App to Install the Router

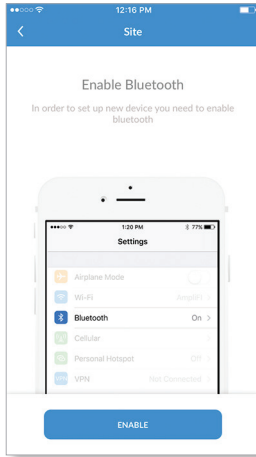
- 1 Launch the AmpliFi app and tap **Continue**.



- 2 Tap **Set Up AmpliFi**.



- 3** iPhone® Users: Ensure that Bluetooth is enabled.
Android™ Users: Ensure that Wi-Fi is enabled.




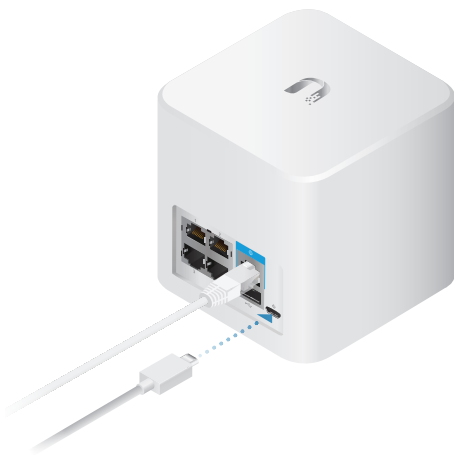
- 4** Power off your broadband modem.



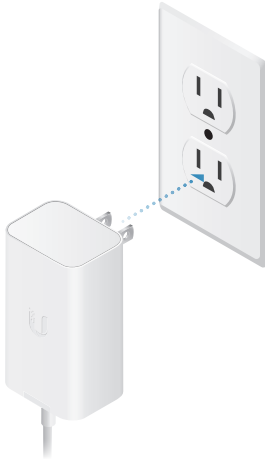
- 5** Connect the *Ethernet Cable* from your broadband modem to the Internet  port on the AmpliFi Router.



- 6** Connect the *Power Adapter* to the port labeled with the power  icon on the AmpliFi Router.



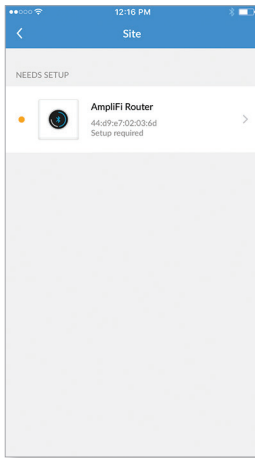
7 Connect the *Power Adapter* to a power outlet.



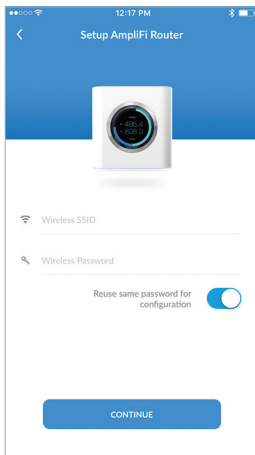
8 Power on your broadband modem.



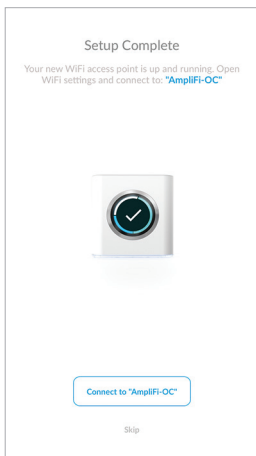
9 Select the AmpliFi Router.



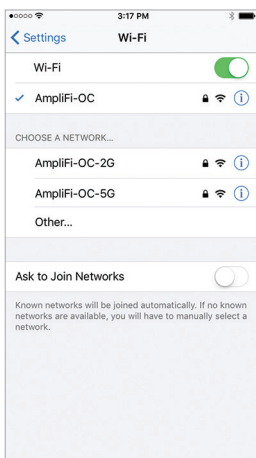
10 Enter a wireless SSID (wireless network name) and a wireless password. Tap **Done** to finish the settings and then tap **Continue**.



- 11** Router setup is complete. Tap **Connect to** <Wireless Network Name>. Android users: proceed to the section titled *Installing the Extenders*.

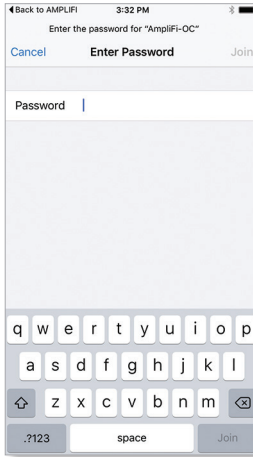


- 12** Select the wireless network name entered in step 10.

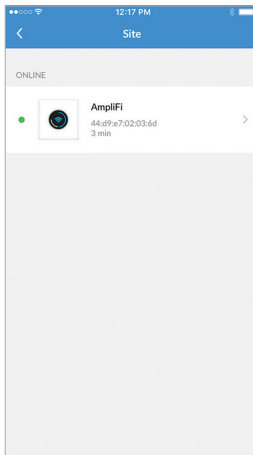

- 13** Type the wireless password entered in step 10 and tap **Join**.



- 14** Your device should connect to the AmpliFi Router. Tap **Back to AmpliFi** and it should appear online.



Installing the Super Extenders

Find a suitable location for each Super Extender with an accessible power outlet. The Super Extenders should be placed in different directions between the router and the areas farthest from the router.



If a Super Extender is powered on and does not appear online in the app, the signal is too weak and the Super Extender should be relocated closer to the Router.

- 1 Plug the Super Extender base into a power outlet.




- 2** Insert the Super Extender antenna into the Super Extender base.

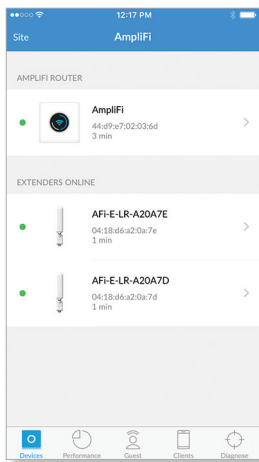


- 3** The Super Extender antenna can be adjusted to provide optimal signal coverage for your location.



-  All LEDs will be lit when receiving an excellent signal from the AmpliFi Router. If the Link LED is flashing then the AmpliFi Router is not connected.

- 4** The Super Extenders will automatically pair with the AmpliFi Router and will appear online in the app after a few moments.
