# 1 Appearance Description

## 1.1 Overview of Fisheye Camera

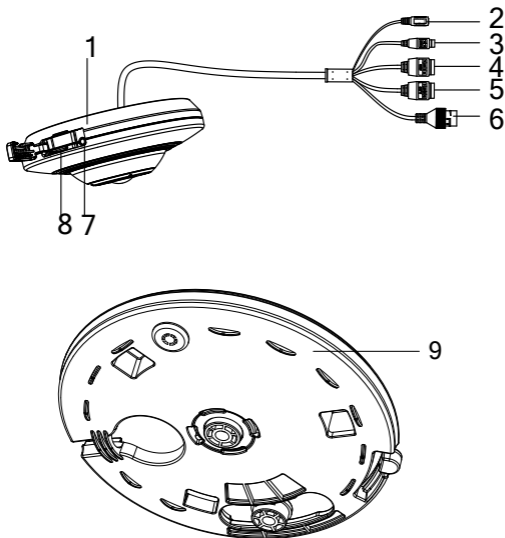


Figure 1-1 Overview of the Fisheye Camera

**Notes:**

- The figures shown in this manual are for reference only. The appearance and interfaces of the camera are subject to the actual model.
- Press RESET about 10s when the camera is powering on or rebooting to restore the default settings, including the user name, password, IP address, port No., etc.

## 2 Installation

---

### *Before you start:*

- Make sure the device in the package is in good condition and all the assembly parts are included.
- The standard power supply is 12V DC or PoE (802.3af), please make sure your power supply matches with your camera.
- Make sure all the related equipment is power-off during the installation.
- Check the specification of the products for the installation environment.
- Make sure that the wall is strong enough to withstand four times the weight of the camera and the bracket.

For the camera that supports IR, you are required to pay attention to the following precautions to prevent IR reflection:

- Dust or grease on the dome cover will cause IR reflection. Please do not remove the dome cover film until the installation is finished. If there is dust or grease on the dome cover, clean the dome cover with clean soft cloth and isopropyl alcohol.
- Make sure that there is no reflective surface too close to the camera lens. The IR light from the camera may reflect back into the lens causing reflection.
- The foam ring around the lens must be seated flush against the inner surface of the bubble to isolate the lens from the IR LEDs. Fasten the dome cover to camera body so that the foam ring and the dome cover are attached seamlessly.



## 2.1 Installing the Memory Card

### Steps:

1. Move the Memory Card/Reset Cover aside, and you can see the reset button and the memory card slot.
2. Insert the memory card into the memory card slot.
3. Re-cover the reset button and memory card slot.

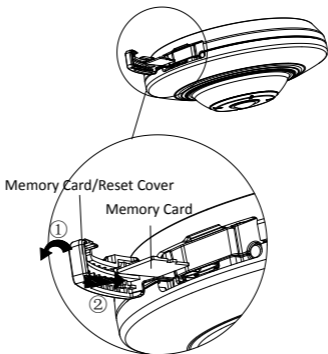


Figure 2-1 Install the Memory Card

## 2.2 Ceiling Mounting

### Steps:

1. Drill two screw holes and the cable hole according to the supplied drill template.

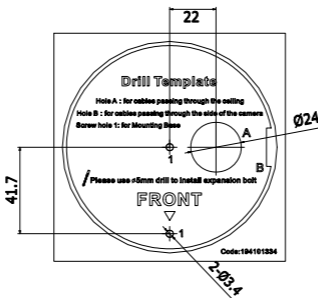


Figure 2-2 Drill Template

2. Align the screw holes and cable hole on the drill template and the base plate, and then fix the base plate to the ceiling with the two supplied screws.

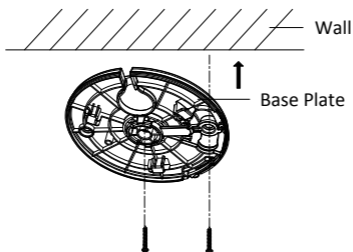


Figure 2-3 Fix the Base Plate

**Notes:**

- For cement wall, you need to use the expansion screw to fix the mount.
  - For wooden wall, you can just use the self-tapping screw to fix the mount.
3. Route the cables through the cable hole or the side opening according to the actual needs, and connect the corresponding cables including power cable, network cable, audio and alarm cables, etc.
  4. Align the triangle mark on the camera and base plate, and then rotate the camera clockwise until it is locked up by the three bayonet joints on the base plate.

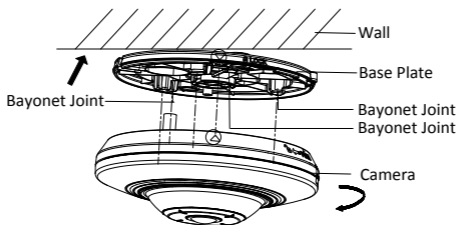


Figure 2-4 Install the Camera

5. To disassemble the camera: Press the **Push** button on the base plate, rotate the camera anticlockwise, and then you can remove the camera from the base plate.

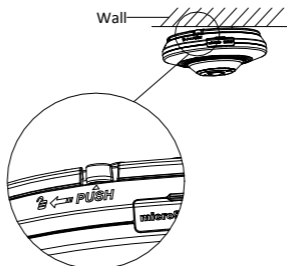


Figure 2-5 Disassemble the Camera

6. To adjust the view angle: Rotate the camera body clockwise or anticlockwise with the base plate, and then you can adjust the camera to the desired view angle.

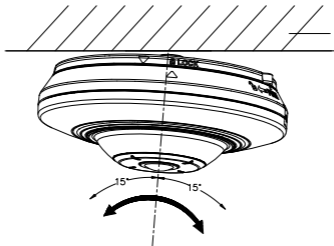


Figure 2-6 Adjust View Angle

## 2.3 Wall Mounting with a Slant Mounting Base

### *Before you start:*

The wall mounting with a slant mounting base provides a wider surveillance view compared to the wall mounting.

You need to purchase a slant mounting base separately if this mounting method is selected.

### *Steps:*

1. Drill two screw holes and the cable hole according to the supplied drill template.

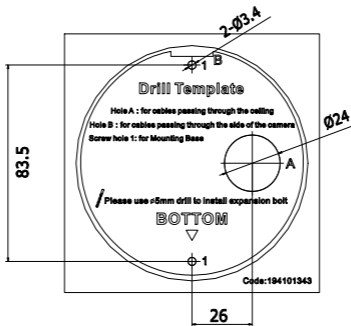


Figure 2-7 Drill Template

2. Fix the slant mounting base to the wall with the screws.

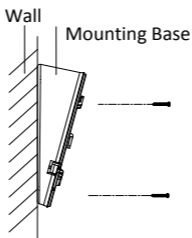


Figure 2-8 Fix the Slant Mounting Base

3. Align the screw holes on the slant mounting base and the base plate, and then secure the base plate on the slant mounting base with the two supplied screws.
4. Route the cables through the cable hole or the side opening according to the actual needs, and connect the corresponding cables including power cable, network cable, audio and alarm cables, etc.
5. Align the triangle mark on the camera and mounting base, and then rotate the camera clockwise until it is locked up.

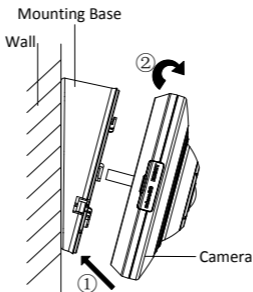


Figure 2-9 Fix the Camera

6. The installation is complete.

7. To disassemble the camera: Press the **Push** button on the base plate, rotate the camera anticlockwise, and then you can remove the camera from the base plate.

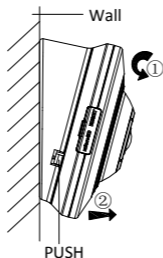


Figure 2-11 Disassemble the Camera



## 2.4 Wall Mounting with a Bracket

### *Before you start:*

You need to purchase the bracket separately if this mounting method is selected.

### *Steps:*

1. Unfasten and remove the screw marked in the figure, and then disassemble the bracket.

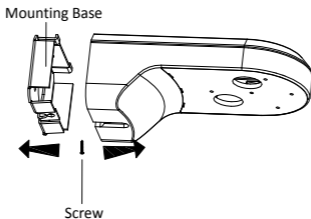


Figure 2-12 Disassemble the Bracket

2. Align the screw holes on the bracket and the base plate, and then secure the base plate on the bracket with the two supplied screws.

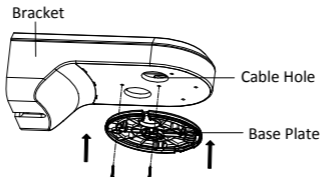


Figure 2-13 Secure the Base Plate

3. Route the cables through the cable hole according to the actual needs, and connect the corresponding cables including power cable, network cable, audio and alarm cables, etc.
4. Align the triangle mark on the camera and base plate, and then rotate the camera clockwise until it is locked up by the three bayonet joints on the base plate.

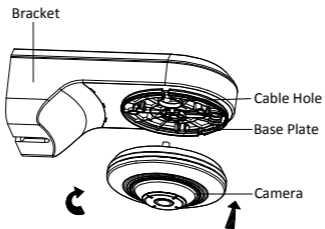


Figure 2-14 Fix the Camera

5. Fix the mounting base to the wall with the screws.

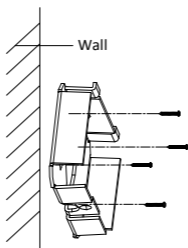


Figure 2-15 Fix the Mounting Base

6. Re-install the main body of the bracket to the mounting base, and fix it with the screw.

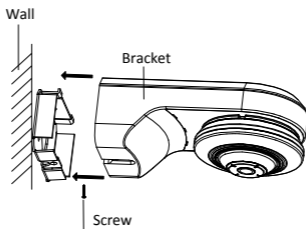


Figure 2-16 Re-install the Bracket

7. To disassemble the camera, refer to the *Step 5 in Section 2.1*.
8. To adjust the view angle, refer to the *Step 6 in Section 2.1*.

## 2.5 Pendant Mounting with a Bracket

### *Before you start:*

You have to purchase the bracket separately if this mounting method is selected.

### *Steps:*

1. Fix the pendant bracket to the wall with the supplied screws.

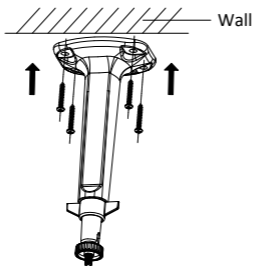


Figure 2-17 Fix the Bracket

2. Aim the screwed hole on the camera at the top of the pendant bracket, and then rotate the camera until it is secured tightly.

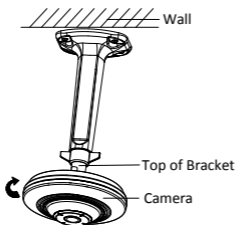


Figure 2-18 Secure the Camera

3. Loosen the knob on the bracket and adjust the camera body to get the desired surveillance angle. Tighten the knob on bracket to secure the camera.

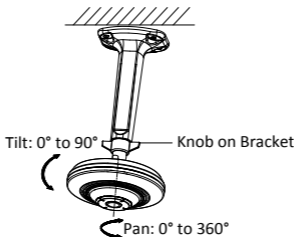


Figure 2-19 Adjust the Angle

## 3 Setting the Network Camera over the LAN

### Note:

You shall acknowledge that the use of the product with Internet access might be under network security risks. For avoidance of any network attacks and information leakage, please strengthen your own protection.

If the product does not work properly, contact your dealer or the nearest service center for help.

### 3.1 Wiring

Connect the camera to network according to the following figures.

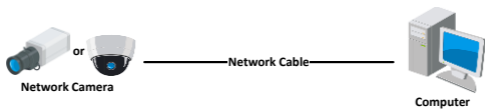


Figure 3-1 Connecting Directly

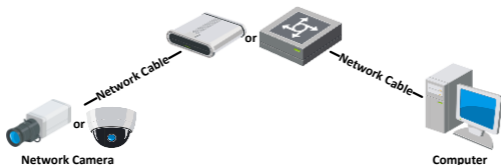


Figure 3-2 Connecting via a Switch or a Router

## 3.2 Activating the Camera

You are required to activate the camera first by setting a strong password for it before you can use the camera.

Activation via Web Browser, Activation via SADP, and Activation via Client Software are all supported. We will take activation via SADP software and Activation via Web Browser as examples to introduce the camera activation.

**Note:**

Refer to the User Manual of Network Camera for Activation via Client Software.

### 3.2.1 Activation via Web Browser

**Steps:**

1. Power on the camera. Connect the camera to your computer or the switch/router which your computer connects to.
2. Input the IP address into the address bar of the web browser, and press Enter to enter the activation interface.

**Notes:**

- The default IP address of the camera is 192.168.1.64.
- The computer and the camera should belong to the same subnet.
- For the camera enables the DHCP by default, you need to use the SADP software to search the IP address.

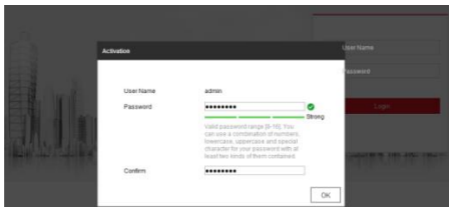


Figure 3-3 Activation Interface(Web)

3. Create a password and input the password into the password field.



**STRONG PASSWORD RECOMMENDED**– *We highly recommend you create a strong password of your own choosing (using a minimum of 8 characters, including upper case letters, lower case letters, numbers, and special characters) in order to increase the security of your product. And we recommend you reset your password regularly, especially in the high security system, resetting the password monthly or weekly can better protect your product.*

4. Confirm the password.
5. Click **OK** to save the password and enter the live view interface.

### 3.2.2 Activation via SADP Software

SADP software is used for detecting the online device, activating the camera, and resetting the password.



Get the SADP software from the supplied disk or the official website, and install the SADP according to the prompts.

Follow the steps to activate the camera.

### Steps:

1. Run the SADP software to search the online devices.
2. Check the device status from the device list, and select the inactive device.

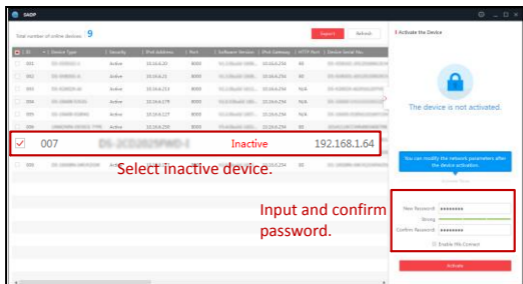


Figure 3-4 SADP Interface

### Note:

The SADP software supports activating the camera in batch. Refer to the user manual of SADP software for details.

3. Create and input the new password in the password field, and confirm the password.

You can enable the Hik-Connect service for the device during activation. Refer to Chapter 5.1 for detailed information.

4. Click **Activate** to start activation.

You can check whether the activation is completed on the popup window. If activation failed, make sure that the password meets the requirement and try again.

### 3.3 Modifying the IP Address

**Purpose:**

To view and configure the camera via LAN (Local Area Network), you need to connect the network camera in the same subnet with your PC.

Use the SADP software or client software to search and change the IP address of the device. We take modifying the IP Address via SADP software as an example to introduce the IP address modification.

For IP address modification via client software, refer to the user manual of client software.

**Steps:**

1. Run the SADP software.
2. Select an active device.
3. Change the device IP address to the same subnet with your computer by either modifying the IP address manually or checking the checkbox of Enable DHCP.

## 4 Accessing via Web Browser

---

### **System Requirement:**

CPU: 2.0 GHz or higher

Web Browser: Internet Explorer 8.0 and above version, Apple Safari 5.0.2 and above version, Mozilla Firefox 5.0 and above version and Google Chrome 18 and above version

### **Steps:**

1. Open the web browser.
2. In the browser address bar, input the IP address of the network camera, and press the **Enter** key to enter the login interface.

#### **Note:**

- The default IP address is 192.168.1.64. You are recommended to change the IP address to the same subnet with your computer.

3. Input the user name and password.

The admin user should configure the device accounts and user/operator permissions properly. Delete the unnecessary accounts and user/operator permissions.

#### **Note:**

The device IP address gets locked if the admin user performs 7 failed password attempts (5 attempts for the user/operator).

### 4. Click **Login**.

### 5. Install the plug-in before viewing the live video and managing the camera. Follow the installation prompts to install the plug-in.

## 5 Operating via Hik-Connect App

---

### *Purpose:*

Hik-Connect is an application for mobile devices. With the App, you can view live image of the camera, receive alarm notification and so on.

### *Note:*

Hik-Connect service is not supported by certain camera models.

### 5.1 Enable Hik-Connect Service on Camera

#### *Purpose:*

Hik-Connect service should be enabled on your camera before using the service.

You can enable the service through SADP software or web browser.

#### 5.1.1 Enable Hik-Connect Service via SADP Software

##### *Steps:*

1. Check the checkbox of **Enable Hik-Connect** on:
  - 1). "Activate the Device" page during camera activation, refer to Chapter 3.2.2.
  - 2). Or "Modify Network Parameters" page during modifying IP address, refer to Chapter 3.3.
2. Create a verification code or change the verification code.

**Tips** [X]

To enable Hik-Connect service, you need to create a verification code or change the verification code.

Verification Code

6 to 12 letters or numbers, case sensitive. You are recommended to use a combination of no less than 8 letters or numbers.

3. Select Platform Access Mode as Hik-Connect.
4. Check the checkbox of Enable.
5. Click and read "Terms of Service" and "Privacy Policy" in pop-up window.
6. Create a verification code or change the verification code for the camera.

### Note:

The verification code is required when you add the camera to Hik-Connect app.

7. Save the settings.

## 5.2 Hik-Connect Setup

### Steps:

1. Download and install the Hik-Connect app by searching “Hik-Connect” in App Store or Google Play™.
2. Launch the app and register for a Hik-Connect user account.
3. Log in Hik-Connect app after registration.

## 5.3 Adding Camera to Hik-Connect

### Before you start:

You need to enable the Hik-Connect service on camera before adding it to your Hik-Connect account. Refer to Chapter 5.1.

### Steps:

1. Use a network cable to connect the camera with a router if the camera does not support Wi-Fi.

### Note:

After the camera connects to the network, please wait one minute before any operation on the camera using Hik-Connect app.

2. In the Hik-Connect app, tap “+” on the upper-right corner and then scan the QR code of the camera to add the camera.

You can find the QR code on the camera or on the cover of the Quick Start Guide of the camera in the package.

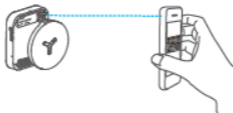



Figure 5-4 Scan QR Code

**Note:**

If the QR code is missing or too blur to be recognized, you can also add the camera by tapping the  icon and inputting the camera's serial number.

3. Input the verification code of your camera.

**Note:**

- The required verification code is the code you create or change when you enabling Hik-Connect service on camera.
- If you forget the verification code, you can check the current verification code on **Platform Access** configuration page via web browser.

4. Follow the prompts to set the network connection and add the camera to your Hik-Connect account.

**Note:**

For detailed information, refer to the user manual of the Hik-Connect app.

## 5.4 Initializing the Memory Card

Check the memory card status by tapping on the Storage Status in the Device Settings interface.

If the memory card status displays as Uninitialized, tap to initialize it. The status will then change to Normal. You can then start recording any event triggered video in the camera such as motion detection.
