


Figure 1-1 Overview (1)




Figure 1-2 Overview (2)




Figure 1-3 Overview (3)

- To reset the camera default parameters, you need to press and hold the RESET button and power on the camera. After the power on of the camera, you must still press and hold the Reset button for about 20 seconds.
- The type of auto-iris interface is shown as below figure:




Figure 1-4 Auto-iris Interface

Power, Video and GND pins are used when the auto-iris is driven by video; Damp+, Damp-, Drive+ and Drive- pins are used when the auto-iris is driven by DC.

2 Installation

Before you start:

- Make sure the device in the package is in good condition and all the assembly parts are included.
- The standard power supply is 12V DC or 24V AC, please make sure your power supply matches with your camera.
- Make sure all the related equipment is power-off during the installation.
- Check the specification of the products for the installation environment.
- Make sure that the wall is strong enough to withstand four times the weight of the camera and the bracket.

For the camera that supports IR, you are required to pay attention to the following precautions to prevent IR reflection:

- Dust or grease on the dome cover will cause IR reflection.
 Please do not remove the dome cover film until the installation is finished. If there is dust or grease on the dome cover, clean the dome cover with clean soft cloth and isopropyl alcohol.
- Make sure that there is no reflective surface too close to the camera lens. The IR light from the camera may reflect back into the lens causing reflection.
- The foam ring around the lens must be seated flush against the inner surface of the bubble to isolate the lens from the IR LEDS.
 Fasten the dome cover to camera body so that the foam ring and the dome cover are attached seamlessly.

2.1 Ceiling Mounting

Steps:

 Install the ceiling mount to the ceiling with the supplied expansion screws.

Fit the lens (not supplied) to the camera and rotate it to get it tightened.



- Install the adapter ring to the lens interface if a C-mount lens is used.
- A manual-iris lens can be directly installed to the camera without plugging the power cable of the auto-iris to the auto-iris interface.

3. Plug the auto-iris cable to the auto-iris interface.




Figure 2-2 Install the Lens

- Align the screw hole on the camera with the ceiling mount and rotate the camera to get it fixed.
- 5. Adjust the surveillance angle.
 - 1). Loosen the pan nut to adjust the pan angle [0°-360°].
 - Loosen the knob on the ceiling mount to adjust the tilt angle [0°-90].
- 6. Adjust the Lens
 - 1). Connect the VIDEO OUT interface of the camera to the debugging monitor.
 - Adjust the Zoom Lever and Focus Level to obtain a perfect image on the monitor.




Figure 2-3 Install the Camera to the Mount and Adjust the Angle

2.2 Wall Mounting

Steps:

- 1. Install the lens (not supplied) to the camera and rotate it to get it tightened.
- 2. Plug the auto-iris cable to the auto-iris interface.




Figure 2-4 Install the Lens



You need to use the CS adapter ring if C type lens is adopted.



3. Fix the bracket to the wall with the screws.




Figure 2-5 Install the Wall Bracket

 Align the camera to the pedestal, and fix the camera with the supplied screws.




Figure 2-6 Install the Camera to the Bracket

- 5. Adjust the Lens
 - 1). Connect the VIDEO OUT interface of the camera to the debugging monitor.

 Adjust the focus level to obtain a perfect image on the monitor.



Please do not remove the lens cap until you finish the installation to avoid the scrape and dust during the installation and wiring.

- 6. Adjust the camera angle to the optimal surveillance angle.
 - 3). Loosen the tilt adjust screw to adjust the tilt angle $[0 \sim \pm 45^{\circ}]$.
 - 4). Loosen the pan adjust screw to adjust the pan angle [0°~360°].
 - 5). Tighten the screws.




Figure 2-7 Adjust the Surveillance Angle



For the camera equipped with the auto iris, it is suggested you change the iris mode to manual from the camera menu (accessed via web browser), and re-change it back to auto iris after you adjust the focus by the focus lever. (Optional) For the camera supports ABF, you can adjust the focus manually, or click the ABF button on the rear panel of the camera to adjust the focus automatically.

2.3 Installing the SD Card

- Insert the SD card to the SD card slot to get it installed.
- Push the inserted SD card slightly to get it sprung by its built-in springing to remove it.




Figure 2-8 Install the SD Card

3 Setting the Network Camera over the LAN

Note:

3.1 Wiring

Connect the camera to network according to the following figures.




Figure 3-2 Connecting via a Switch or a Router

3.2 Activating the Camera

You are required to activate the camera first by setting a strong password for it before you can use the camera.

Activation via Web Browser, Activation via SADP, and Activation via Client Software are all supported. We will take activation via SADP software and Activation via Web Browser as examples to introduce the camera activation.

Note:

Refer to the User Manual of Network Camera for Activation via Client Software.

3.2.1 Activation via Web Browser

Steps:

- 1. Power on the camera. Connect the camera to your computer or the switch/router which your computer connects to.
- Input the IP address into the address bar of the web browser, and press Enter to enter the activation interface.

Notes:

- The default IP address of the camera is 192.168.1.64.
- The computer and the camera should belong to the same subnet.
- For the camera enables the DHCP by default, you need to use the SADP software to search the IP address.

- 3. Create a password and input the password into the password field.
 - STRONG PASSWORD RECOMMENDED- We highly recommend you create a strong password of your own choosing (using a minimum of 8 characters, including upper case letters, lower case letters, numbers, and special characters) in order to increase the security of your product. And we recommend you reset your password regularly, especially in the high security system, resetting the password monthly or weekly can better protect your product.
- 4. Confirm the password.
- 5. Click **OK** to save the password and enter the live view interface.

3.2.2 Activation via SADP Software

SADP software is used for detecting the online device, activating the camera, and resetting the password.

Get the SADP software from the supplied disk or the official website, and install the SADP according to the prompts.

Follow the steps to activate the camera.

Steps:

- 1. Run the SADP software to search the online devices.
- 2. Check the device status from the device list, and select the inactive device.

Create and input the new password in the password field, and confirm the password.

4. Click Activate to start activation.

You can check whether the activation is completed on the popup window. If activation failed, make sure that the password meets the requirement and try again.

3.3 Modifying the IP Address

Purpose:

To view and configure the camera via LAN (Local Area Network), you need to connect the network camera in the same subnet with your PC.

Use the SADP software or client software to search and change the IP address of the device. We take modifying the IP Address via SADP software as an example to introduce the IP address modification.

For IP address modification via client software, refer to the user manual of client software.

Steps:

- 1. Run the SADP software.
- 2. Select an active device.
- Change the device IP address to the same subnet with your computer by either modifying the IP address manually or checking the checkbox of Enable DHCP.

The batch IP address modification is supported by the SADP. Refer to the user manual of SADP for details.

4 Accessing via Web Browser

System Requirement:

Operating System: Microsoft Windows XP SP1 and above version

CPU: 2.0 GHz or higher

RAM: 1G or higher

Display: 1024×768 resolution or higher

Web Browser: Internet Explorer 8.0 and above version, Apple Safari 5.0.2 and above version, Mozilla Firefox 5.0 and above version and Google Chrome 18 and above version

Steps:

- 1. Open the web browser.
- In the browser address bar, input the IP address of the network camera, and press the Enter key to enter the login interface.

Note:

- The default IP address is 192.168.1.64. You are recommended to change the IP address to the same subnet with your computer.
- 3. Input the user name and password.

The admin user should configure the device accounts and user/operator permissions properly. Delete the unnecessary accounts and user/operator permissions.

Note:

The device IP address gets locked if the admin user performs 7 failed password attempts (5 attempts for the user/operator).

4. Click Login.

5 Operating via Hik-Connect App

Purpose:

Hik-Connect is an application for mobile devices. With the App, you can view live image of the camera, receive alarm notification and so on.

Note:

Hik-Connect service is not supported by certain camera models.

5.1 Enable Hik-Connect Service on Camera

Purpose:

Hik-Connect service should be enabled on your camera before using the service.

You can enable the service through SADP software or web browser.

5.1.1 Enable Hik-Connect Service via SADP Software

Steps:

- 1. Check the checkbox of Enable Hik-Connect on:
 - 1). "Activate the Device" page during camera activation, refer to Chapter 3.2.2.
 - Or "Modify Network Parameters" page during modifying IP address, refer to Chapter 3.3.
- 2. Create a verification code or change the verification code.

5.1.2 Enable Hik-Connect Service via Web Browser

- 1. Access the camera via web browser. Refer to Chapter 4.
- Enter platform access configuration interface: Configuration > Network > Advanced Settings > Platform Access

- 3. Select Platform Access Mode as Hik-Connect.
- 4. Check the checkbox of Enable.
- Click and read "Terms of Service" and "Privacy Policy" in pop-up window.
- Create a verification code or change the verification code for the camera.

Note:

The verification code is required when you add the camera to Hik-Connect app.

7. Save the settings.

5.2 Hik-Connect Setup

Steps:

- Download and install the Hik-Connect app by searching "Hik-Connect" in App Store or Google Play[™].
- 2. Launch the app and register for a Hik-Connect user account.
- 3. Log in Hik-Connect app after registration.

5.3 Adding Camera to Hik-Connect

Before you start:

You need to enable the Hik-Connect service on camera before adding it to your Hik-Connect account. Refer to Chapter 5.1.

Steps:

 Use a network cable to connect the camera with a router if the camera does not support Wi-Fi.

Note:

After the camera connects to the network, please wait one minute before any operation on the camera using Hik-Connect app.

In the Hik-Connect app, tap "+" on the upper-right corner and then scan the QR code of the camera to add the camera. You can find the QR code on the camera or on the cover of the Quick Start Guide of the camera in the package.

Note:

If the QR code is missing or too blur to be recognized, you can also add the camera by tapping the discontant inputting the camera's serial number.

3. Input the verification code of your camera.

Note:

- The required verification code is the code you create or change when you enabling Hik-Connect service on camera.
- If you forget the verification code, you can check the current verification code on Platform Access configuration page via web browser.
- Follow the prompts to set the network connection and add the camera to your Hik-Connect account.

Note:

For detailed information, refer to the user manual of the Hik-Connect app.

5.4 Initializing the Memory Card

Steps:

Check the memory card status by tapping on the Storage Status in the Device Settings interface.

If the memory card status displays as Uninitialized, tap to initialize it. The status will then change to Normal. You can then start recording any event triggered video in the camera such as motion detection.
